On January 7, 2020, I was invited by the Institute of New Dimensions to give a lecture about Erik Prince, the story of Blackwater, his current private security companies around the world, and the geopolitical implications of having private mercenary armies and intelligence services being created by both state and non-state actors.

On November 5, 2019, I was invited by The American Whig-Cliosophic Society at Princeton University to discuss the Mueller Investigation, what to expect going forward with the upcoming release of the grand jury material and Donald Trump's tax returns, why the Department of Justice has a guideline that a sitting President cannot be indicted, and the impeachment inquiry into Donald Trump and the corruption regarding Ukraine with individuals such as Rudy Giuliani and Paul Manafort.

On October 17 and October 24, 2019, I was invited by the Institute of New Dimensions to host a two-week course about the rise of Vladimir Putin and the development of the twenty-first century Russian state following the collapse of the Cold War and the fall of the Soviet Union and what it has meant for the United States and the rest of the world when it comes to geopolitics.

On October 3, 2019, I was invited by the College Democrats at NYU to lecture about the key elements of the Iran Nuclear Deal, the geopolitical implications of the Trump Administration pulling out of the agreement, and some of the potential motives behind the administration withdrawing and re-establishing sanctions against Iran that involve discussing the alliance of the United States and Saudi Arabia, the alliance of the United States and Israel, the alliance of Russia and Iran, the relationship between Jared Kushner and Saudi Crown Prince Mohammad Bin Salman Al Saud, and the relationship between Saudi Crown Prince Mohammad Bin Salman Al Saud and Emirati Crown Prince Mohammed bin Zayed Al Nahyan.

On September 27, October 3, and October 10, 2019, I hosted a three-week course about the Mueller Investigation in which I explain the events in 2017 that led up to the appointment of Robert Mueller as Special Prosecutor, the scope of the investigation as established by the Department of Justice, the legal precedents established for the role of Special Prosecutor, the legal team that worked alongside Robert Mueller, what has been uncovered so far either by Mueller or separate federal investigations about conspiracy between the Trump

campaign and Russia, along with any business dealings between the Trump Organization and the Kremlin both before and during the presidential campaign, the quid pro quo scandal involving Trump and Giuliani with Ukraine, and how other organizations like the National Rifle Association, Deutsche Bank, and Qatar Investment Authority have all been investigated.
